

**SUMMARY ANNUAL REPORT**

This is a summary of the annual report for BELLAVANCE TRUCKING HEALTH & WELFARE BENEFIT PLAN, 45-4002868/501/Health (other than dental/vision), Health reimbursement account (HRA), Life insurance, Accidental death and dismemberment (AD&D), Dental, Vision, Temporary disability, Long-term disability, and Employee assistance program (EAP) for the period 1/1/2019 through 12/31/2019. The annual report has been filed with the Employee Benefits Security Administration, formerly known as the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BELLAVANCE TRUCKING, INC. has committed itself to pay certain (HRA and Dental) claims incurred under the terms of the plan.

The plan has contracts with INVEST EAP, SECURITY MUTUAL LIFE INSURANCE COMPANY OF NEW YORK, THE VERMONT HEALTH PLAN, VISION SERVICE PLAN, and RENAISSANCE LIFE & HEALTH INSURANCE COMPANY OF AMERICA to pay certain (Health (other than dental/vision), Life insurance, AD&D, Vision, Temporary disability, Long-term disability, and EAP) claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2019 were \$1,044,981.
